# Up Front, In Front, AND PREPARED FOR THE FUTURE

In 2024, we advocated on a broad range of children's policy issues before state departments, the Ohio General Assembly, the Governor's office, and federal leaders. Through these efforts, the Ohio Children's Alliance is a leader in advancing policies that improve the lives of children, youth, and families across Ohio. We remain committed to strengthening public-private partnerships, protecting funding for critical services, and ensuring that every child has access to the care and support they need to thrive.

#### **Administrative Policy & System Reform**

Shaped multiple administrative rules and policy frameworks to improve child welfare and behavioral health services, including:

- Provided detailed feedback and engaged members on the Continuous Certification Rule Process at the Ohio Department of Children and Youth (DCY), ensuring a two-year continuing education structure and expanded continuing education options for professionals.
- Helped design the Child Match Platform, an online tool connecting foster youth with appropriate placements, ensuring efficiency and user-friendliness for child welfare
- Advocated for flexibility in DCY licensure rules, ensuring access to rehabilitation options for those fostering or working in children's services.
- Provided key insights on the implementation of Next Generation Managed Care and OhioRISE measures, assisting members with billing questions and pushing for Medicaid system improvements.
- Weighed in on federal mental health parity rules and kinship care support changes, influencing policies that strengthen both child welfare and behavioral health systems nationally.



#### **Legislative Advocacy & Workgroups**

Played a leading role in shaping and supporting key legislative efforts to improve services for Ohio's children and families:

- Adoption Modernization Act (HB 5) Played a key role in advocating for HB 5, which modernizes Ohio's adoption process by increasing financial support for expectant mothers, expediting kinship care adoption timelines, and streamlining legal procedures. The bill was enacted and takes effect in March 2025.
- Foster-to-College Bill (House Bill 164 & Senate Bill 182) Worked closely with legislative sponsors and stakeholders to advance this important measure, which would provide tuition support for youth aging out of foster care.
- Placement Crisis Solutions (House Bill 512) Engaged in discussions regarding emergency placement facilities and were named stakeholders in the Placement Solutions Workgroup, which seeks to address the foster care placement crisis and expand treatment foster care and community-based solutions.
- DCY Residential Facility Regulations (House Bill 583) Took a leading role in discussions surrounding HB 583, advocating for balanced reforms that strengthen oversight while ensuring facilities have the necessary tools and protections to operate effectively.
- ADAMH Board and Provider Contracting Reform (Senate Bill 105)

Worked with policymakers to shape this bill, which affects behavioral health providers statewide by reforming how local ADAMH Boards contract with community providers.

#### **Federal Advocacy**

At the national level, we played a role in securing meaningful reforms, including:

- Passage of the Find and Protect Foster Youth Act, ensuring that states prioritize tracking and locating missing foster youth while improving data collection and reporting on vulnerable children.
- Ongoing engagement with federal agencies on Medicaid behavioral health policies, advocating for improved reimbursement rates and policy consistency for community-based providers.

# **EXECUTIVE RETREAT**

#### Bringing together stakeholders to strengthen the future

The Alliance's inaugural executive retreat provided a vital space for leaders across 26 community agencies to step away from their daily operations and focus on the bigger picture—how to not only sustain but transform the system of care for the next decade. Gathering 36 executives from organizations across the state, the retreat fostered meaningful peer connections, in-depth discussions on industry trends, and strategic planning around managed care, evolving regulations, and the role of Al and technology in service delivery. The retreat gave participants the opportunity to engage in forward-thinking conversations, in-person collaboration, and the chance to build stronger networks for the future of children services.

# **ALLIANCE PROGRAMS**

# A holistic, data-driven approach to shaping the future

The Alliance oversees 7 programs and provides administrative support to the Collaborative, Ohio's first and largest clinically integrated network of community behavioral health providers. Through partnerships with public and private organizations, community change-makers, and government agencies, the Alliance leads numerous programs that strengthen Ohio's system of care.



#### CHILD AND ADOLESCENT BEHAVIORAL **HEALTH CENTER OF EXCELLENCE (COE)**

This statewide program strengthens care for children with complex behavioral needs by training providers and improving system coordination. We accomplish this through organized learning communities, strategic mini-grants for professional development, and immersion learning experiences at conferences.



#### FOSTER HOME RECRUITMENT

Increasing awareness and the number of qualified kinship, foster care, and adoptive families across the state, in partnership with ODCY It Takes Heart Ohio™ Campaign.





#### **MENU OF SUPPORTS**

New pilot program in 2024! Empowering community agencies and foster/kinship caregivers to increase the availability of placement options to serve children in need of placement through a financial incentive approach.





#### OHIO REACH

Supports former foster youth as they pursue a certificate or degree through a network of higher education institutions across the state.

New Micro-Grant program for Ohio Reach Postsecondary Designated Institutions, allowing institutions of higher education to fund innovative new programs, including housing stipends, a career closet, mentorship programs, and more for young adults who have experienced the foster care system.



A proactive approach connecting Ohio child care centers and parents with a statewide network of mental health providers that have expertise and certification in early childhood mental health addressing immediate concerns as well as longterm mental health and resilience. Investing in mental health benefits our youngest Ohioans and their families as well as their communities and future generations.



#### THERAPEUTIC CHILD CARE (TCC)

Behavioral health providers partnered with child care centers to deliver services that support, compliment, and enhance a center's ability to sustain enrollment for children with complex behaviors and emotions.

# **FOSTERING FUTURES**



Lexi's participation in the inaugural Fostering Futures program has given her the opportunity to develop professional culinary skills and gain valuable life lessons in patience, communication, and teamwork. While she was initially hesitant to join, she overcame her doubts with encouragement and thrived in the 16-week program, learning from industry experts at Columbus State Community College. With support from The Buckeye Ranch, including career coaching and financial assistance, Lexi successfully completed the program and is awaiting a paid internship from Cameron Mitchell Restaurants. Looking ahead, she is determined to achieve financial stability and pursue her lifelong dream of earning a degree in marine biology.

#### **OHIO REACH**

Jay's journey through the foster care system was filled with uncertainty, multiple placements—some loving, others traumatic—and the harsh reality of falling through the cracks. Forced into independent living at 16, Jay struggled with financial instability, homelessness, and a lack of a safety net while pursuing college. The absence of resources and support led to hardships, but also fueled a passion for ensuring that other foster youth don't face the same challenges. Now with Ohio Reach, foster youth are connected to vital education, housing, and financial resources—all of the things that she wishes she had access to while in the foster care system. Through resilience and advocacy, Jay has turned pain into purpose, proving that the right support can transform lives.

### **MENTAL HEALTH BRIDGE**



Mental Health Bridge expanded access to high-quality, individualized mental health services to young children enrolled in child care through the development of a secure, online referral software solution. It also cultivated a network of early childhood mental health providers able to offer services at their organization, at the child's home, and at the child care center.

Funding for Mental Health Bridge was provided to Ohio Children's Alliance through the Ohio Department of Children and Youth. The pilot program began in July 2022 and concluded on June 30, 2024.

ADVANCING BEHAVIORAL HEALTH CARE AND SOCIAL SERVICES INNOVATION

The Collaborative is a nonprofit corporation and subsidiary of the Ohio Children's Alliance consisting of more than 40 community agencies who work together to advance value-based care and social services innovation across the state.

# **CLINICALLY INTEGRATED HEALTH CARE NETWORK (CIN)**



In 2024, our collaborative efforts drove system-wide improvements in foster care and behavioral health services through strategic value-based contracting and network expansion. We grew our provider network from 34 to 39 agencies. By securing value-based agreements with payors, providers are incentivized to improve outcomes in critical areas such as seven-day follow-ups, medication adherence, and reducing hospital admissions.

A significant focus has been supporting agencies in navigating Ohio's Next Generation Medicaid program, particularly the implementation of the Provider Network Management (PNM) system. Through shared learning workgroups and a coding and billing learning community, we have helped members adapt to system changes, streamline credentialing, and reduce administrative barriers. These initiatives underscore the power of collaboration—bringing providers together to enhance care, share best practices, and collectively improve outcomes.

#### **Housing for Daniel**

During the referral process, several Regional Coordinators from the Collaborative met regularly with Daniel and his service team to create a comprehensive transition plan. This plan aimed to ensure a smooth enrollment into the Bridges program for Daniel. The service team, which included the assigned Bridges Provider agency, secured adequate funding and found appropriate housing for him. They also assisted Daniel in acquiring additional items for his new home.

#### RESPITE CARE

This past year marked significant progress in expanding and strengthening respite care services across our network. **Providers delivered high-quality care, growing the network by adding new providers and increasing referrals by over 100%.** 

Agencies also leveraged respite care not only as a critical support for families but as a work-force development tool to train and retain providers. Investments in training, technical assistance, and an enhanced referral platform increased the number of children served. As a large statewide provider of behavioral health respite in OhioRISE, our network drives best practices, advocacy, and capacity-building efforts that benefit providers and families statewide.



"Although we have always offered respite services through our continuum of care, the number of respites we are currently providing has substantially increased.

Our foster families that have adopted special needs children are finding it as a huge resource. This offers many families an extra support to help preserve the family upon reunification."

#### **FOOD SECURITY PROGRAM**





Launched in May 2024, our screening and referral pilot program is a focused but powerful initiative aimed at addressing food insecurity among families receiving behavioral health services. In collaboration with Beech Brook and Integrated Services for behavioral health, two provider agencies serving both urban (Cuyahoga) and rural (Athens) communities, the program integrates food security screenings into new referrals.

Families identified as food insecure receive a continually updated Food Resource Guide, connecting them to local food banks, SNAP application assistance, and other critical supports.

The pilot, supported by UnitedHealthcare®, highlights the deep connections between food access and mental health, bringing this issue to the forefront. The initiative has already demonstrated impact, with increased screenings and stronger community awareness.

## SPRING CONFERENCE

The Spring Conference brought together experts and leaders to explore critical topics in child services, with a strong focus on trauma-informed care and youth mental health. Dr. Bruce Perry gave a presentation on the profound impact of trauma and neglect on child development. Becky Haas shared practical strategies for integrating trauma-informed approaches into our communities. And Tia Marcel Moretti. Chief Advisor for OhioMHAS, delivered an inspiring keynote, celebrating the successes of OhioRISE and outlining the DeWine administration's vision for strengthening youth mental health services over the next 1,000 days.

# FALL CONFERENCE

The Fall Conference provided a dynamic platform for leaders to exchange ideas and explore innovative approaches to strengthening child and youth services. Director Amy Ast (Youth Services) and Chief Advisor Tia Marcel Moretti (OhioMHAS) shared key updates on statewide initiatives. The morning featured engaging TED-style presentations, with Pam Scott (The Buckeye Ranch) highlighting the importance of transforming new hire orientation into meaningful moments of connection. DeShon Clark (Allventa) explored the transformative potential of AI in child services, while Brice Mickey (Beech Acres Parenting Center) and Matt Kresic (Cadence Care Network) underscored the role of creativity in sustaining and evolving organizations.



Both conferences reinforced the power of collaboration, innovation, and **strategic thinking** in shaping the future of youth services.






